

Privacy Policy

Thank you for visiting the Janibid.com, or Easycleaningsystems.com websites (Sites), which are owned by Janibid LLC, an California Limited Liability Company (Janibid) and reviewing our Privacy Policy, effective April 18, 2017. Janibid is committed to safeguarding your privacy online. Please read the following policy to understand how your personal information will be treated as you make full use of our many services.

Overview

This Privacy Policy (Policy) governs your use of the Sites. This Policy describes the information we collect from you and what may happen to that information. For example, this Policy will let you know what information we collect from you; what cookies are and how they are used; how your information is used; who is collecting your information; with whom your information may be shared; what options are available to you regarding collection, use, and distribution of your information; how you may use other users' information; the types of security precautions in place to protect against loss, misuse, or alteration of your information; how Janibid protects children's privacy; and other important information about your online privacy.

Please note that we review our privacy practices from time to time, and that our practices are subject to change. We ask that you periodically review this document to ensure continuing familiarity with the most current version of our Privacy Policy. All amended terms shall be automatically effective after they are posted on the Sites.

By visiting the Sites, you agree to be bound by the terms and conditions of this Privacy Policy. If you do not agree with the terms of this Privacy Policy, please do not use or access the Sites.

What Personally Identifiable Information does Janibid collect?

The primary purpose of collecting information from you is to provide you with a safe, smooth, effective, and personalized experience. We will only collect information about you that we consider necessary to achieve this purpose.

Generally, Janibid collects information in several ways. Some information is gathered when you register. This includes your name, company name, mailing address, phone number, email address, User Name, password and credit card information. Where possible, we indicate which fields are required and which fields are optional. We also collect personal information when you report a problem, either through the Sites' email, direct mail, or via telephone. We may also ask for personal information at other times, including, but not limited to, when you make payments to Janibid. If you contact Janibid, we may keep a record of that correspondence. We also may ask you questions in a survey concerning your cleaning business or when gathering data to prepare a bid, the answers to which are never associated with any personally identifiable information but are viewed for general customer feedback and satisfaction as well as for the purpose of making our system more accurate for all users and subscribers.

Wherever Janibid collects personal information, we make an effort to include a link to this Privacy Policy on that page.

What are "cookies" and how does Janibid use them?

Data collection devices, such as "cookies," are used to store, and sometimes track, information about you. Generally, these cookies help provide personalized services and promote trust and safety. A cookie is a small file containing a small amount of data that is sent to your browser from a web server and placed on your computer's hard drive to assist us in providing our services. All pages on the Sites where you are prompted to login or that are customizable may require that you accept cookies. Cookies are only read by the server that placed them and are unable to execute any code or virus. Most cookies are "session cookies" and are automatically deleted from your hard drive at the end of a session. More specifically, we may use cookies to:

1. Remind us of who you are when you login and to access your account information in order to deliver to you a more personalized service;
2. Measure your visiting patterns in the aggregate. Aggregate data (data gathered across all user accounts) may be gathered in a non-personally identifiable form to build higher quality, more useful online services by performing statistical analyses of the collective characteristics and behavior of our visitors, such as how long and how often users and subscribers view certain pages;
3. Determine your click stream to our Sites;
4. Better personalize the content that you and other users and subscribers will see on our Sites; and
5. Collect IP addresses for system administration.

How does Janibid use my information?

Janibid uses your information to provide you with a customized browsing experience. We also may use your personal information to process orders (like submitting your credit card, name and zip code to the credit card processor so your payment goes through properly); resolve disputes; troubleshoot problems; respond to your inquiries; detect and protect against error, fraud, or other criminal activity; and enforce our User Agreement. Janibid also reserves the right to use your data, without linking it to you personally, for the purpose of determining accuracy of building data used by our system to make the bidding process easier and more effective for you.

Additionally, we may use your information to contact you about products or services we, affiliated companies, or authorized vendors may have to offer. You may cancel your authorization for this at any time.

Who is collecting information?

When you are using the Sites and are asked for personal information, you are sharing that information with Janibid, affiliated companies and our authorized vendors, unless we specifically state otherwise or unless we are processing a payment during which information is given to the credit card processor. If data is being collected and/or maintained by any company other than Janibid its affiliated companies and/or authorized vendors, you will be notified prior to the time of the data collection or transfer.

Please be advised that Janibid advertisers or websites that have links on our Sites may collect personally identifiable information about you. The information practices of those websites linked to Janibid Sites are not covered by this privacy statement.

With whom do Janibid sites share my information?

Other Janibid users will not have access to any personally identifiable bid information you enter such as the company name, contact name or location of any building you are bidding on. In addition, Janibid will not sell or distribute your personally identifiable bid information.

Janibid will not disclose your personally identifiable information except with our affiliated companies or authorized vendors, unless we have your permission or under special circumstances, such as those described below.

External Service Providers: Separate services may be offered by third parties, also known as external service providers. If you choose to use these services, disclose information to these parties, and/or grant them permission to collect information about you, their privacy policy governs the use of your information. When you inquire about or purchase such services via the Sites, Janibid shares your information with that external services provider so that they may complete your request.

Janibid Employees and Contractors: Some of our employees and contractors are subject to non-disclosure agreements with us. These and other legal restrictions prohibit their use of the information you provide us for any purpose except to facilitate the specific Janibid related operation, unless you explicitly agreed or gave your prior permission to them for additional uses.

Advertisers:

If you complete a transaction with an advertiser linked to Janibid, the information obtained during your visit to that advertiser, and the information you give, may be provided to the advertiser. Advertisers linked to the Sites have separate policy practices for which Janibid has no responsibility or liability.

Other:

We may disclose account information where we have reason to believe that disclosing the information is necessary to identify, contact, or bring legal action against someone who may be violating Janibids policies as specified in the Privacy Policy or User Agreement, violating state or federal law, or may be causing injury to or interference with (either intentionally or unintentionally) Janibids rights or property, other Sites users or subscribers, or anyone else that could be harmed by such activities. Janibid may disclose or access account information when we believe in good faith that the law requires it and for administrative and other purposes that we deem necessary to maintain and improve our Sites or Services.

We cannot ensure that all of your private communications and other personal information will never be disclosed in ways not otherwise described in this Policy. For example, we may be forced to disclose information to the government or third parties under certain circumstances, third parties may unlawfully intercept or access transmissions or private communications, or users or subscribers may abuse or misuse your personal information that they unlawfully collect from the Sites. We use industry standard practices to protect your privacy, however, we do not promise, and you should not expect, that your personal information or private communications will always remain private.

What are my choices regarding collection, use, and distribution of my information?

Janibid will contact you if you complete a contact form on the Sites, if you sign up for a membership, or if you contact us directly by email. We may also send you emails regarding our products and services. Only Janibid, our affiliated companies, authorized vendors, or agents working on behalf of Janibid, will contact you. Janibid may communicate with you via telephone, email, or direct mail. How may I use other users' information?

Specifically, but not as a limitation, you agree to comply with all applicable laws regarding transmission of technical and personal data exported from the United States or the country in which you reside.

Spam:

We do not tolerate spam. You are not licensed to add us or any registered user to your mail (email or physical mail) list without his or her affirmative consent. You are not licensed to use spam in promoting Janibid.

What security precautions are in place to protect the loss, misuse, or alteration of my information?

Whenever Janibid handles your personal information, we take steps to ensure that your information is treated securely and in accordance with the relevant User Agreement and this Policy. Your information is stored on our servers located in the United States.
